**NOTICE FOR INVITATION OF RATES/QUOTATIONS FOR SUPPLY OF STATIONERY ITEMS
(SUB-HEAD AO-3901), FINANCIAL YEAR 2026-2027.**

The Provincial Intelligence Fusion & Threat Assessment Centre (PIFTAC) invites sealed quotations from registered and experienced firms/suppliers for the supply of stationery items on a rate-contract basis for the Financial Year 2026-2027, under Rule 45(b) of the GB-PPRA Rules, 2022 (Request for Quotations).

1. The estimated value of the procurement is below Rs. 1,000,000/-; the procurement is therefore being processed as a Request for Quotations under Rule 45(b) of the GB-PPRA Rules, 2022 (as amended vide S.R.O. 1665(I)/2023, which raised the request-for-quotations ceiling from Rs. 500,000 to Rs. 1,000,000) and does not require open advertisement.
2. Quotation documents (terms and price schedule) may be collected from the PIFTAC Office, SPU Compound, Sakwar, Gilgit during working hours.
3. Sealed quotations, complete in all respects, must reach the PIFTAC Office, SPU Compound, Sakwar, Gilgit, on or before 19-08, 2026, and shall be opened the same day at 12:00 hours.
4. The supplier must be registered (SECP / relevant registration) and hold a valid NTN (and GST where applicable); an affidavit that the firm has never been blacklisted must be attached. A valid vendor number is also MANDATORY — only suppliers holding a valid vendor number should apply, as government payments to vendors are now made online.
5. Bid security is not required for procurement under Request for Quotations (Rule 45b).
6. Conditional/optional quotations shall be treated as non-responsive.
7. The quotation of only those firms shall be considered who fulfil the mandatory documents/eligibility conditions; the lowest evaluated responsive quotation shall be accepted.
8. The rates quoted must be realistic and inclusive of all applicable taxes; unrealistic/zero rates shall render the quotation liable to rejection.
9. The Competent Authority reserves the right to accept or reject any or all quotations under the GB-PPRA Rules, 2022.
