TENDER NOTICE.

Sealed tenders are invited from reputed registered Government firms/dealers/supplier/contractors for procurement of the below category of goods/services for AIG Police Special Branch Gilgit-Baltistan, Gilgit is required (Transport Repair, Stationary, Other Miscellaneous, Diet Feed for Sniffer Dog, Repair of Machinery & Equipment's) for the Financial Year 2026-27. Last date for submission of complete documents/forms etc. and bid/tenders will be opened on 29.07.2026 (09:30 am to 01:30 pm).

TERMS & CONDITIONS:-

1. Sealed tenders may be submitted to undersigned before the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at AIG Police Special Branch Gilgit-Baltistan, Gilgit.
2. Contractor/Supplier/ has complete set up (own shop, and past experience with documentary evidence in the relevant field).
3. The Contractor/Supplier must be sole proprietor/ Certificate of Chamber of Commerce having his own complete setup (shops) containing adequate supplies in Gilgit Town and he will be bound to supply demanded items at the AIG Police Special Branch Gilgit-Baltistan, Gilgit.
4. The Bid Security/call deposit in shape of Bank Draft / Pay Order by a Scheduled bank in the name of "AIG Police Special Branch Gilgit-Baltistan, Gilgit." CDRs (for Transport Repair Rs.300,000/- and other heads for Rs.100,000/- each) may be attached with the bidding/tender documents. Tender without call deposit from a scheduled bank, will not be accepted.
5. The bidding document of only registered firms/dealers/suppliers/contractors shall be entertained.
6. The rates of items if not covered in the "Prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply.
7. *Tenders for Stationary, Other Miscellaneous, Diet Feed for Sniffer Dog, Repair of Machinery & Equipment's will be entertained subject to allocation of budget above (01 million) in case the budget less than 01 million the tender will be entertained on Quotation basis (under the GB PPRA S.R.O 1665(1)2023).*
8. Conditional, ambiguous & incomplete tenders shall not be accepted.
9. Bank statement for the last 03 years, work Experience in relevant field (03 years) and Registration Certificate, Vendor Number must be attached with bidding documents duly attested.
10. The procedure of single stage two envelopes shall be followed and tender shall be evaluated as per weight age/ratio of 70:30 formula "70 for technical proposal and 30 for financial proposal".
11. The competent authority reserves the right to accept or reject any one or all of the tenders as per relevant instructions/ guidelines of GB PPRA rules.
