## Terms & Conditions:

- a) Tender Documents / RFP containing detailed terms and conditions can be obtained from the office of the Director General, Gilgit-Baltistan Disaster Management Authority (near Jail Building. Minawar Gilgit), during working days between 9:00 AM to 4:00 PM, up to the last day (one hour before the tender opening time).
- b) The bidder must have experience in the supply of at least three (03) projects of similar nature. (Supply orders must be duly attested by the concerned department/organization).
- c) A copy of the tender will be issued only to registered firms/suppliers/manufacturers/contractors, either in person or through an authorized representative, on production of an original CNIC and valid renew/updated Firm Registration Certificate (2025).
- d) The firm must be financially and technically sound and shall complete the supplies within the stipulated time.
- e) The Single Stage Two Envelope procedures will be adopted as per GB PPRA Rule 39(B).
- f) Sealed envelopes must clearly mention the tender title.
- g) All tenders must be accompanied by the required earnest money (as mentioned in the above relevant column) from any scheduled bank, in the form of Pay Order / Bank Draft in favor of DG GBDMA. The original Pay Order / CDR must be attached with the Technical Proposal.
- h) All tenders must reach the office of the Director General, Gilgit-Baltistan Disaster Management Authority (near Jail Building, Minawar Gilgit), by 14-10-2025 at 10:00 AM. The tenders will be opened on the same day at 10:30 AM in the presence of bidders or their authorized representatives by the constituted committee at the office of DG GBDMA.
- i) Overwritten, ambiguous, conditional, or void tenders are liable to rejection.
- j) Submission of item samples as per NIT is mandatory along with the tender documents. Samples will be tested during the technical evaluation, and only those firms whose samples and technical proposals qualify will be considered for financial bidding.

k) The interested firm must provide an attested affidavit of "No Litigation" and "Non-Blacklisting."

The successful firm shall be bound to supply the relief items at the GBDMA Main Warehouse. Minawar Gilgit, within the timeline specified in the contract agreement.

m) The tender (NIT) fee shall be deposited in the Treasury Office Gilgit, and the original deposit slip

must be attached with the NIT (Technical Proposal).

n) The Procurement Committee reserves the right to accept or reject any or all tenders, with reasons duly recorded, as per GB PPRA Rule-36.

o) The procuring agency shall dis-qualify a supplier if it finds at any time that the information submitted by him concerning his qualification as supplier was false and materially inaccurate or

incomplete as per GB PPRA Rule-21.

p) In case of JV agreement, it should be executed on proper format duly signed by both partners of JV clearly mentioning the share of each partner and lead partner duly attested by magistrate 1<sup>st</sup> Class. Both JV members should have the required above mentioned terms and conditions section (B) experience
