**INVITATION FOR BIDS**

Gilgit Baltistan Board of Revenue invites sealed bids from the eligible bidders/rental transport companies/firms for hiring of vehicles on rental basis for ETI Land Titling Project, till 31st December 2026, which may be extended further subject to extension of the project and on satisfactory performance, as per following detail, under GB PPRA Rules 2022: -

1	Vehicle preferably 4*4 with driver, having engine capacity 2200cc to 3000 cc; Model 2010 or newer, atleast 04 persons seating capacity, adequate storage space for luggage vehicle rent/month (repair/spare, mobile oil change, driver salary and per diem charges (per month rent/charges).	04


**TERMS & CONDITIONS: -**

1. Registered rental transport companies /firms (need to submit the certificate of incorporation).
2. Vehicles may either be regular registered **OR** NCP indexed with Excise and Taxation Department, GB.
3. Vehicles should be in good condition.
4. Minimum 03 years of experience (post-registration) providing such type of services on a rental basis business, preferably with government/semi-government/autonomous bodies.
5. Financial Position, Bank Statement for three years.
6. Affidavit of not being blacklisted.
7. Proof of Backup support facilities. The company must ensure the availability of additional vehicles, with the same specification, as a backup.
8. Tax Registration for non-local firms or contractors.
9. A non-refundable **tender fee of Rupees Six Thousand (Rs.6000)** must be submitted along with the tender documents.
10. The bid security/Call deposit (refundable) in shape of bank draft of **Rs. 0.3 million** by a schedule bank in the name of **DDO GB Board of Revenue** must be attached with the (Technical Documents) bidding/tender documents. Tender without call deposit from a schedule bank will not be entertained.
11. Repair, maintenance, engine oil change, and the services of the drivers will be the responsibility of the company/contractor.
12. Provision of details for Fuel Management system/ multiple fueling points in every district.
13. Each Company provides the best possible lowest Rate on the following alternative options.
  - i. Rent of vehicles per month and with fuel charges of 300 liter per month.
  - ii. Rent of vehicles per day and with fuel charges of 10 liter per day.
14. The bids should be submitted in **sealed envelopes** clearly mentioning "Tender Proposal for Transportation Services".
15. The **Single Stage-ONE envelope** procedure, as outlined in Section 39(B) of the GB PPRA Rules, will be adhered to. Firms that meet the eligibility criteria and mandatory conditions will undergo a technical evaluation. To qualify for the financial evaluation, a minimum score of 70% is required. Preference will be given to firms offering the lowest rates. The bid that is deemed most advantageous will be accepted.



16. The Department reserves the right to reject any proposal or bid, or cancel the entire evaluation process at any time before acceptance and award of the contract, and may increase or decrease no. of vehicles, as per GB PPRA rules.

Registered Transport Companies/Firms may submit their bids with all required documents within the next 15 days of the advertisement in the office of the GB Board of Revenue new Secretariat Building Jutial Gilgit on or before **11:00 AM** on **24<sup>th</sup> July, 2026**. The bids will be opened on same date in the presence of bidders or their authorized representatives at 11:30 AM.
