- The interested bidders will submit their bids on the above-mentioned date & time which will be opened on the **same day shown above against each scheme** in the Conference Hall situated at M & CH complex SSGT Hospital Gilgit in presence of the bidders or their authorized representatives who choose to attend. If the day of bid opening is observed as local or national holiday, the bid will be open on next working day on same time and venue.
- The bidders shall purchase bidding documents for detailed Terms & Conditions ,specifications of items and guidelines ,from the ORD Store Office SSGT Hospital Gilgit on written request and payment of **Rs. 12,000/-** (Non-refundable) on any working day (9am -2pm) before bid closing hours.
- 3% bid security in the shape of a Call Deposit Receipt (CDR) only from any scheduled bank, in favor of Medical Superintendent SSGT Hospital Gilgit must accompany with the tender documents/bids. The CDR will remain with the Procuring Agency until the successful completion of bidding process and award of contract.
- A verifiable authority letter from Manufacturers (OEM) and Sole distributors (in case of sub distributors) must also be provided with the technical bids for verifications.
- The bid shall remain valid for 180 days.
- Rates will be inclusive of all relevant taxes.
- As per GBPPRA Rules 2022 Clause 39(a), single-stage One-envelope bidding procedure will be adopted for this National competitive bidding.
- The procuring agency reserves the right to increase, decrease, accept, or reject any item or all the tender with the reasons assigned thereof.
- A pre-bid meeting will be held 7 days before the opening of bids for any kind of clarification. A bidder who obtained the bidding document from the above-mentioned office may submit his written clarification on any clause of bidding documents in the pre bid meeting, and the same shall be addressed by the Procurement committee well before bid submission date.
