- 03. The fee of tender forms will be accepted through Treasury challan in the relevant revenue head of account

- 05. The bidding documents will be issued to firms/contractors subject to production of 2% bid security in shape of CDR/TDR issued by any schedule bank in Pakistan.
- 06. Rate quoted below 10% of the Technical Sanction shall be considered as unworkable, however. The bidder quoting rates below 10% of TS shall be required to provide along-with his bids an additional performance guarantee of 50% of the differential amount (between TS and bid) in shape of CDR from any schedule Bank.
- 07. In case of Gazette holyday/local holyday, tender shall be opened on next working day without further intimation.
- 08. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank, in shape of CDR in favor of Employer valid for a period of 28 days beyond the bid validity date.
