**3. MUST MEET TERMS AND CONDITIONS:**

- i. Original departmental No litigation/No sick scheme certificate on the behalf of office of the Secretary Works C&WD in prescribed format for year 2025-26.
- ii. Original renewal receipt in Works Department GB is required for the financial year 2025-26.
- iii. Copy of National Identity card (owner of the firm).
- iv. Only project specific power of attorney on the behalf of CEO/MD/Director of firm is accepted if provided on judicial stamp paper duly sign and stamp by 1<sup>st</sup> Class Magistrate.
- v. Contractors/Firms having more than 03 works in hand in Communication & Works Department shall be discouraged.
- vi. Firm/JVs must provide 2% earnest money in the form of call deposit receipt (CDR) in favor of the Executive Engineer B&R C&WD Nagar from any schedule bank. The CDR must emboss original signature of the authority; electronic signed CDR will not be acceptable.
- vii. The firms/JVs shall not be qualified if already awarded work is delayed or sick without any justification/reason. A certificate from the concern Executive Engineer is required to be attached in this regard.
- viii. Applications of those contractors whose names are included in the list of sick projects and their name forwarded to PEC for cancellation of their license will not be considered for evaluation process.
- ix. Each Firm/JVs is eligible to obtain bidding document for only one project. Multiple requests for bidding document to different projects by the same Firm/JVs will not be entertained.
- x. The Bidder quoted rates below 10% of T/S Estimate shall be required to provide along with his bid an additional performance guarantee of 10% differential amount (between T/S and Bid) in shape of CDR from any schedule bank of Pakistan. In case of failure to produce the required differential amount of bid by the bidder along with his bid documents, the bid shall be rejected and original CDR amount shall be forfeited.
- xi. The CDR of all unsuccessful bidders will be released after expiry of bid validity or formal approval of tender which one is earlier.
- xii. **The procuring agency reserves the right to reject all bids or proposals at any time before accepting a bid or proposal, in accordance with (Rule 36 of GBPPRA Rules as amended vide SRO dated 9<sup>th</sup> September, 2022).**
- xiii. If in any case the local holiday will be observed on the date of opening of Bid then next working day will the opening day of bid with same time and conditions.
