TERMS AND CONDITIONS: -

1. A complete set of bidding Documents containing detailed terms and conditions may be obtained by an interested eligible bidder from the Office of AD GBDMA Gilgit.
2. In accordance with GB PPRA Rule-28; Bid Security as indicated is required in shape of CDR, Bank Draft or Bank Guarantee in favor of undersigned from any schedule bank dully mentioned the name & title of the firm, along with sealed Financial Proposals.
3. Contract / suppliers may offer tender in which they have complete setup, own shop, store, work shop with all documentary evidence.
4. The contractor / supplier must adequate supply/ stock in Gilgit and the firm will be bound to supply demanded items and same rates as well.
5. Separate envelope containing technical and financial proposal must be submitted before the closing date and time accordingly.
6. If provided rates are not similar to market rates then this office has the authority to cancel the rates.
7. The rates of the items not listed in the "prescribed form" will be determined in accordance with the prevailing retail price / market rate at the time of supply. The contractor / supplier will not have to right to challenge the market rates collected from the market by the concerned staff of the GBDMA office Gilgit.
8. The tender rates list provided by the firm to this department must be in computerized print form. Hand written tender rates list is not acceptable.
9. The procuring committee shall disqualify a supplier if it finds at any time that the information submitted by him concerning his qualification as supplier was false and materially inaccurate or incomplete as per GB PPRA rule -21.
10. The tender (NIT) fee shall be deposited in the Treasury Office Gilgit , and the original deposit slip must be attached with the NIT(Technical Proposal)
11. The firm is responsible for mistakes / wrong calculations in the tender rate list.
12. No bidding document will be issued through post, telegraph or E-Mail and on day of opening. The undersigned in accordance with GB PPRA Rule-36 of 2022 may reject all bids or proposals any time prior to the acceptance of a bid or proposal.
