TENDER NOTICE

Gilgit-Baltistan Police invites sealed bids under the PPRA Rules-2022 from well-reputed, financially sound and having experienced firms/contractors/suppliers registered with the Income Tax (where applicable) for the supply of stationery items to Central Police Office Gilgit for the financial year 2026-27. Bids shall be addressed to AIG Police Logistics CPO and must be received by 11:00AM on 3rd August 2026. The bids will be opened at 11:30AM on the same day.

Terms and conditions

1. Sealed bids may be submitted to the undersigned before the closing date/time (as given above). The bids will be opened by the committee in the presence of contractors/suppliers or their authorized representatives at Central Police Office Konodas, Gilgit.
2. Separate sealed envelopes containing **Technical proposal** and **financial proposal** must be submitted before the closing date/time. Only those bidders who fulfill Technical requirements (as per evaluation criteria) shall qualify for the opening of financial proposals.
3. Contractors/suppliers may submit bids only for those category of tender, in which they have complete business setup (own shop/store etc) supported by duly attested documentary evidence.
4. The contractor/supplier shall be bound to supply the required items/services to CPO Gilgit at the approved rates throughout the financial year 2026-27.
5. A Separate tender of each category shall be submitted, clearly mentioning the category name in bold letters on the sealed envelope.
6. A bid security/call deposit equal to 03% of the total allocated budget in the shape of bank draft from a scheduled bank in the name of AIG Police Logistics CPO Gilgit must be attached with the Technical proposal. Proposals submitted without call deposit shall not be entertained.
7. Only bids/proposals submitted by registered firms/dealers/suppliers/contractors will be entertained.
8. If the rates of any item are not included in the prescribed form, it shall be determined accordance to the prevailing retail /market rates at the time of supply.
9. All applicable taxes (where applicable) shall be included in the bid price and borne by the firms/suppliers.
10. Conditional, ambiguous, or incomplete bids shall not be accepted.
11. Abnormally high or unusually low rates quoted by the bidder shall be rejected.
12. The competent authority reserves the right to accept or reject any or all bids without assigning any reason.
13. The rates of the offered items must be filled/entered in a computerized format. Manually filled/entered rates will not be accepted.
