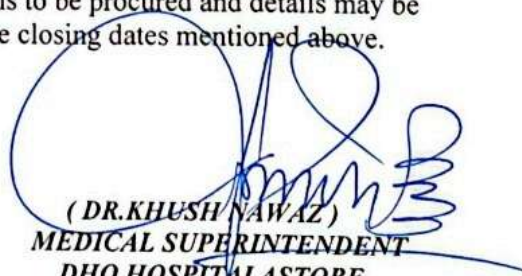

6. All kind of taxes may be included in the bid price and shall be borne by the firm/dealers /suppliers/contractors.
