The Gilgit-Baltistan Government Servants Benevolent Fund and Group Insurance Department invites bids from well-reputed/registered firms/contractors for procurement of goods and services on account of repair of vehicles for the financial year 2026-27 against the operational account funds of GB-GSBF&GI and development project titled "Establishment of Gilgit-Baltistan Government Servants Benevolent Fund & Group Insurance Department". General Terms and Conditions: -

- i. The firm or the company must be registered under the relevant laws.
- ii. Earnest money @ Rs. 3% bid value must be attached with the bid in shape of demand draft/pay order/CDR in the name of **Managing Director (BF&GI)**, Gilgit-Baltistan, Gilgit.
- iii. Bids must reach to the office of the undersigned on **29th June, 2026 at 12:00 PM**. Bids will be opened on the same day in the office of **Managing Director (BF&GI)** at **12:30 PM** in presence of Contractors or their authorized representatives.
- iv. Incomplete bids and without supporting documents shall not be entertained, and furnishing false information shall be liable to legal action.
- v. An affidavit on stamp paper of **Rs. 100/-** must be attached (in original prepared after the date of publication of this notice) with the bid to the effect that the bidder has never been blacklisted by any Government/Semi-Government Organization/PPRA.
- vi. The Firm/Contractor shall be bound to supply/install the items on quoted rates, whereas the items not mentioned in the bid document, the contractor shall be bound to supply those items on market rates.
- vii. Firm/Company having their own shop/outlet can apply only for which document having valid proof of shop/outlet showing address must be attached.
- viii. The procedure of bid under PPRA Rules 39(b) single stage two envelope shall be followed. Firm/contractor needs to submit separate proposals for Technical & Financial clearly indicating the name of Firm/Contractor. Documents provided in a single envelope shall not be considered and shall be rejected.
- ix. Firm/Contractor must have completed minimum **five (05) years of similar/same nature** and supply order/experience certificate/proof of experience must be attached with tender documents. Supply order in relevant field for whole financial year shall also be considered.
- x. No JV is allowed.
- xi. Bank credit transaction at least 2.000 million in the last one year.
- xii. The Managing Director GB GSBF&GI has the right to accept or reject, all or any bid by assigning any reason but doesn't need to justified.
