1. The Executive Engineer GB C&WD B&R Division Skardu has been entrusted by the Government of Gilgit Baltistan for the construction for "Metalling of Baltistan University Road (04-Km) to eligible payment under the contract(s) for which this invitation is issued.
2. The Executive Engineer GB C&WD B&R Division Skardu hereafter the employer intend to procurement under SSTE method for the under mentioned work :
3. Invitation of bid under (SSTE method) is open to constructor/JV contractor who are registered with PEC having relevant Category (specify) for construction operation of Engineering works, described in para -2 mentioned here in above. Applications may be submitted for qualification for the above works.
4. Appropriate of category PEC registered constructor may obtain the qualification documents from the office of the employer, Executive Engineer office GB C&WD B&R Division at Parishan Chowk Skardu and the request to send the same through mail at specified address shall not be entertained.
5. **MANDATORY CONDITIONS:-**
  - i. Registration with PEC for CFY (2026-27) with relevant code and category.
  - ii. Renewal receipt GB-C&W Department for CFY (2026-27).
  - iii. Latest profile of the constructors/firm/JV from PEC website
  - iv. As per directives of Works Secretariat vide Notification No.SW-7/104/Notification/2022-23/3369 dated 18-08-2023, mandatory certificates regarding "No Sick Scheme certificate will be provided to contractor on production of challan of Rs. 5000/- and "No Litigation" will be provided to contractor on production of challan of Rs. 5000/- the mentioned fees shall be deposited in Government treasury through treasury challan and the copy of challan shall be part of each bidding documents of enlisted contractors.
  - v. The competent authority of GB C&WD reserve right to reject any or all application/bid prior acceptance of the application/ bids as per GB PPRA Rule 2022 under clause-36(1).
  - vi. CNIC of the Prospective bidder/firm.
  - vii. Bid security as specified in shape of CDR from any scheduled bank.
  - viii. Page numbering & signing of each page in original shall be mandatory.
  - ix. Only one bid will be entertained either as single bidder or JV partner.
  - x. Bank statement should be properly stamped and signed by the concerned Bank Manager.

- xi. The Qualification and Evaluation Criteria is enclosed with the bidding documents. All bidders are directed to fill the form duly certified on an affidavit on a judicial stamp paper of Rs. 100.
- xii. The Bidding documents are available for a non-refundable fee of **Rs. 14,000/- (Rupees Fourteen Thousand Only)** in shape of Treasury Challan duly passed by the Treasury Officer / NBP Skardu Branch, showing the name of project and constructor
- xiii. Submission of fake, incomplete and faulty documents will be rejected and legal action will be taken accordingly.

#### **GENERAL GUIDELINES.**

- i. The Contractor debarred by any region/division and notified by Works secretariat shall not be eligible to participate in the bidding process in all regions.
- ii. The bid security of unsuccessful bidders shall not be released before the issuance of work order to the successful bidder.
- iii. The bidding documents/tender copy fee may be charged in accordance with the GB Finance Act-2024 given vide schedule-I (Section-12).
- iv. The bidder may submit 02 sets of bidding documents duly addressed to concerned Executive Engineer and one duplicate copy may be addressed to relevant Chief Engineer to ensure transparency.
- v. The pre-bid meeting will be held in the office of the Chairman bid Evaluation committee/Superintending Engineer GB PWD Skardu/Shigar Circle Skardu on 16th July, 2026 at 02:30 PM.
- vi. No bid shall be accepted beyond closing of time as mentioned above.
- vii. In case of any deviation, conflict in bidding procedure the provision of PEC Rule, 2004 & GB PPRA 2022 shall prevail.
- viii. In case of local holiday bid will be opened on next working day without further intimation.
- ix. Clarification of bids shall only be allowed in accordance with GB PPRA Rule 2022 and Standard Bidding Documents relevant clauses.
- x. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank or AA rating insurance company.
- xi. Bids shall be opened in the Office of the Chairman bid Evaluation committee/Superintending Engineer Skardu/Shigar Circle.
- xii. Rates quoted below 10% of the Technical Sanction shall be considered as unworkable and default as per clause 28.4 of bidding documents; however,
  - a. The bidder quoting rates below 10% of TS shall be required to provide along with his bids and additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR from any schedule bank.
  - b. In case of failure to produce the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited.



Technical bid will be opened on 27<sup>th</sup> July, 2026 at 11:30 AM in the office of the Superintending Engineer Skardu-Shigar Circle near Baltoro Rest House Hassan Shaheed Chowk Skardu, the employer reserved the right to accept or reject the late applications.
  - a. Applicant will be informed in due course, of the result of the evaluation of technical bid. Only the firms/Constructor and joint ventures technically qualified under this process will be invited to opening their financial bid intimating time and avenue.
