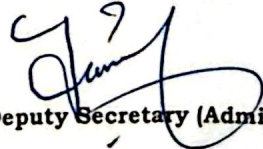

2. The tender documents must reach at office of the undersigned on or before date and time mentioned above. Tender documents will be opened on the same day as schedule given above in presence of bidders or authorized representatives.

GENERAL TERM AND CONDITIONS:-

- I. Call Deposit (only scheduled bank) as mentioned above must be attached with the tender documents in form of demand draft/pay order in the name of Deputy Secretary Forest/DDO, Forest wildlife & Environment Department GB, Gilgit from any scheduled bank.
- II. Bid with incomplete supporting documents shall not be accepted, and furnishing of incorrect information shall be liable to legal action.
- III. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government organization/PPRA.
- IV. Qualified firms/contractors shall be bound to supply the items to Forest, Wildlife and Environment Department during the financial year till 30th June, 2027.
- V. The firm shall be bound to supply/provide/goods/services at rates quoted in bidding document during the financial year 2026-27.
- VI. The contractor must have his own shop/workshop to participate in the tender. Firm/contractor must have **minimum Three (03) years experience** in the relevant field can only participate in tender and supply orders/experience certificate/proof of experience must be attached with tender documents.
- VII. Tender documents containing detail of evaluation criteria, items, work and specifications may be obtained from the office of the undersigned during office hours before closing date and time mentioned above.
- VIII. The procedure of single stage two envelopes shall be followed.
- IX. Quotation must be in computer typed form. Hand-written quotations shall not be entertained.
- X. The department reserves right to accept or reject the tender according to Gilgit-Baltistan PPRA, 2021, Rule-36(1).
- XI. The items which are not mentioned in the bidding documents shall be supplied according to prevailing market rates.
- XII. Copy of CNIC.
- XIII. Cost of tender copy/bidding documents must be deposited through treasury challan, which is mandatory for submission of bidding documents.
- XIV. Registration certificate of firm.
- XV. In case of gazette holiday/local holiday, tender shall be open on next working day.
