TERMS & CONDITIONS.

1. Sealed tender may be submitted to undersigned before the closing date and time, which will be opened by the Committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representative at AD GBDMA office Ghizer.
2. Contractor/Suppliers may offer only that category of tender in which they have complete setup, own shop, store, and workshop with all documentary evidence.
3. The Contractor/supplier must adequate supply/stock in Ghizer and the firm will be bound to supply demanded items and same rate as well.
4. Separate envelope containing technical and financial proposal must be submitted before the closing and time accordingly.
5. Tender for each category must be offered mentioned name of category in bold letters on sealed envelope.
6. The bid security/call deposit (refundable) in shape of bank draft by a scheduled bank in the name of AD GBDMA, Ghizer attached with the (technical documents) bidding/tender documents. Tender without call deposit from a schedule bank will not be entertained.
7. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
8. The rate of items of not in listed in the "Prescribed form" will be determined in accordance with the prevailing retail price/market rate at the time of supply. The contractor/supply will not have to right the challenge the market rates collected from the market by the concerned staff of the GBDMA office Ghizer.
9. Conditional, ambiguous and incomplete tender documents will not be accepted.
10. Banks statement for the last one year, three year experience in relevant field, firm registration certificate, non black listed affidavit, CNIC of the owner, letter paid of the

firm with address, vender No. & telephone must be attached with technical bidding documents dully attested.

11. Irrational/artificial and dubious rates offered by the firm/contractor will be rejected.
12. All kind of taxes applicable (if any) will be inclusive in the bid price and bound by the firms/dealers/suppliers/contractors.
13. The competent authority reserves the right to accept or reject any one or all tenders as per relevant instruction/guidelines of GB PPRA.
14. Firms at least two supply orders of work completion of similar nature, size and complexity as contractor.
15. The tender rates list provided by the firm to these department must be in computerized print form. Hand written tender rates is not acceptable.
16. No bidding documents will issued through post, telegraph or e-mail and on day of opening. The undersigned in accordance with PPRA rule 33 of 2004 may reject all bids or proposals any time prior the acceptance of a bid or proposal.
