**TENDER NOTICE**

The Directorate of Mines and Minerals-Gilgit-Baltistan invites sealed bids from reputed manufacturers, authorized dealers / distributors, vendors, and suppliers for supply and installation of Gemological Equipment, including Raman Spectroscope and FTIR, along with Gemstone Cutting and Polishing Machinery under the project "Upgradation of Lapidary Centre Gilgit and Skardu (EDF)" on the basis of single stage two envelopes bidding process adopting Rule 39(b) of GB-PPRA 2022.

1. The interested firm should have at least five (5) years of experience in relevant nature of work.
2. The Consultant Firm participating in bid must be registered with Security Exchange Commission of Pakistan along with proof.
3. Bid security amounting to five (5) percent of bid value in the shape of Call Deposit should be attached with the quotation. In case CDR not found attached with Technical Bid the firm / contractor will be declared as "Non-responsive".
4. Successful bidders will have to submit 10% Performance Security from any Schedule Bank in the name of Director Mines and Minerals, Gilgit within seven (7) days after bid acceptance.
5. The bidder must maintain a minimum average bank balance of PKR 30 (Thirty) Million in a scheduled bank account for the last twelve (12) months preceding the submission date of the bid. The bidder shall provide a bank statement or a bank certificate as proof of maintaining the required balance.
6. The Tender Document can be obtained only from the Office of the Directorate of Mines & Minerals, KIU Road, Konodas, Gilgit, during office hours on payment of non-refundable amount of Rs. 8000/-(Eight Thousand only).
7. Conditional/Optional quotations will be treated as "Non-Responsive".
8. Irrational rates / Unrealistic rates will not be considered and rejected.
9. An affidavit on Stamp Paper of Rs. 100 must be accompanied with the tender documents to the effect that a bidder has never been black listed by any government/semi-government organization/ PPRA.

0. The Directorate of Mines and Mineral GB is fully empowered to accept or reject all or any of the proposals as per GB Public Procurement Rules, 2022 on the basis of sound reasons thereof.
11. Bidders may submit quotations for one or more items. Each item will be evaluated separately, and award of contract shall be conducted on an item-wise basis.
12. The number of items can be increased or decreased keeping in view the availability of financial resources for the purpose.
13. Bids received after closing date and time will not be accepted.
