The tender documents will be opened on the same day as per schedule given above in the presence of contractor or authorized representatives.

**GENERAL TERMS AND CONDITIONS: -**

01. Tender documents can be obtained from the office of the Director General GBES (Rescue 1122) until 24<sup>th</sup> July, 2026 closing office working hours on written request with original treasury slip/challan by depositing **Rs.4000/- (Rupees Four thousand only)** as tender fee in Treasury Office.
02. Earnest money as mentioned above must be attached with the tender documents in the shape of DD/Pay Order (Refundable) in the name of Deputy Director GBES Rescue 1122 from any schedule Bank.
03. Tenders with incomplete supporting documents shall not be accepted and furnishing incorrect/false information shall be liable to legal action.
04. An affidavit on stamp paper of Rs.100/- must be accompanied with the tender document to the effect that the bidder has never been black listed or barred by any Government/semi Govt. organization /GBPPRA.
05. The firms have own shop for each category (A, B, C) can apply for tender. (The firms must endorse location of shop). The committee will visit of the shop of bidders if deem necessary.
06. The firm has minimum 5 years relevant Experience in category "A" capable in repair of transport work and 01-year relevant experience in category "B & C" (Experience must be attached i-e supply/work orders/contract agreement etc.)
07. Separate transportation charges will not be allowed.
08. The firm/contractor shall be bound to supply the items to GBES (Rescue 1122) HQ office Gilgit till 30<sup>th</sup> June, 2027.
09. Contract shall be terminated on issuing 15 days' notice or /any time before if the department feel dissatisfied with the performance of the contractor.
10. The bid shall be considered lot wise and firm shall be bound to supply/provide goods/services at rates quoted in tender during the financial year 2026-27.
11. **Single stage- one envelope** procedure shall be followed as per **GBPPRA rule 2022 Rule 39(a)**. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the **Financial Proposal** and **Technical Proposal** and also marks in bold and legible letters.
12. The Department reserves the right to accept or reject any one or all the tender according to **GBPPRA rule-36(1)**.
13. It may be checked and ensure that all the cells of the Rate offering column have been filled in and no cell is left unfilled without offering the tender rate against the items (**Including Grant Totals**). If any cell found unfilled or empty, the bidder will be rejected.
14. Bids received after the due date and time will not be entertained. A Firm/Contractor can offer tender for only one category.
15. The rates quoted in the bids should include laboring charges. Separate labor charges will not be allowed.
16. If district Administration will announce local holiday on 27<sup>th</sup> July, 2026, the bid will be opened the very next working day.
17. Other terms and conditions are mentioned in the tender documents in each category and must adhere by the firms and tenders will be evaluated as per terms and conditions accordingly.
