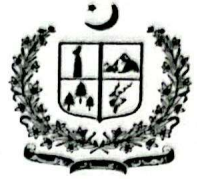

TENDER NOTICE

Gilgit Baltistan Police Department invites sealed bids based on **Gilgit Baltistan Public Procurement Rules (GB PPRA) 2022** from well reputed and financially sound firms having previous experience as well as registered with Sales Tax and Income Tax Department for repair/maintenance and supply of spare parts for CPO vehicles (four / two wheelers) for the financial year **2026-2027**. Bids are to be addressed to the AIG Police Logistics, Central Police Office (CPO), Police Department Gilgit and shall be received till **07-08-2026, 1100 PM** and shall be opened at **1130 hours** on the same day in CPO, KIU Road, Konodas Gilgit. The tender notice is also available on the PPRA's website (www.ppra.gov.pk).

2. The technical bids will be opened on the same date and time mentioned above in presence of the Contractors/Suppliers or their authorized representatives at Central Police Office Gilgit. Financial Proposals shall remain (in sealed form) in the custody of the Police Department and would be opened after receipt of the Technical Evaluation Report, in the presence of the qualified bidders. The technically qualified lowest bid would be accepted. The financial proposal found technically un-acceptable shall be returned un-opened to the respective bidder under the rule.

3. The bids shall be received under **"Single Stage Two Envelope Procedure"** as per clause 39 (b) of GB-PPRA-2022. The bids shall contain separately the **"Financial Proposal"** and the **"Technical Proposal"** with following documents/information noted against each: -

- i) Technical Proposal (Bidding documents, earnest money, sales tax and income tax certificate etc.)
- ii) Financial Proposal (Rate of respective item including all taxes/charges whatsoever on the firm's letter head pad. Rates quoted would be considered if the same are in Pakistani Rupees and inclusive of all taxes/duties/charges.

4. The successful bidders shall deposit equal to 10% of the cost of the work/supplies as Performance Guarantee in the form of call deposit/bank guarantee of a scheduled bank in favour of the AIG Police Logistics, Central Police Office (CPO), Gilgit-Baltistan, Gilgit within the period specified in advance. The contract performance guarantee shall be refunded on successful completion of the contract.

5. The interested firms are required to collect the bidding documents, containing terms & conditions and evaluation criteria etc. from office of the AIG Police Logistics, Central Police Office (CPO), KIU Road Konodas, Gilgit by hand on written request on the firm's letter head pad, during any working day at office hours. As per the notification issued by the Home Department GB, vide letter No. SOFF-3/Revenue/2022-23(F&A) dated 13th May 2025 an amount of **Rs.8000/- (Rupees Eight Thousand only)** has to be submitted to MT Branch CPO to obtain the tender documents. In case of public holiday due to any reason, the date of receiving and opening of the tenders will be next working day.

6. The bidders are required to attach Call Deposit as Bid Security of **Rs. 600,000/- (Rupees Six Lac only)** from a Scheduled Bank in the name of AIG Police Logistics, Central Police Office (CPO), Gilgit. Bids without Call Deposit/Bid Security will not be accepted.
