EXPRESSION OF INTEREST

The Local Government and Rural Development Department (LG&RD), district Shigar, is a district level government department working under the administrative control of the Government of Gilgit-Baltistan and is striving for improved livelihood of masses across Gilgit-Baltistan by providing different services under the provisions of Gilgit Baltistan Local Government Act, 2014.

The LG&RD Department Shigar, on behalf of Government of Gilgit-Baltistan, intends to outsource its Rest House, situated at Chutron, district Shigar on “AS IS WHERE IS BASIS”, and invites Expression of Interest (EoI) from reputed, experienced and financially sound hospitality firms/companies/organizations/private corporations registered under the relevant laws.

The winning party shall convert the existing rest house at Chutron Shigar into a comfortable and attractive tourist destination offering state of the art hospitality services, on lease basis which would help the LG&RD Shigar create its constant source of revenue from the commercial use of the property while simultaneously offering private party an adequate rate of return on their investment. This will not only make effective utilization of the property, but also ensure adequate supply of high-class facilities to the tourists.

The LG&RD Rest House Chutron is a land mark building, made with white locally extracted marble which is situated at a distance of almost 40 kilometers from main Shigar Valley. The road to Chutron is surrounded by newly built modern private luxury resorts, lush green fields, lofty mountains and residential areas. The entire Shigar valley is a tourism hub and receives considerable number of tourists throughout the year. The property has two independent blocks (each having two rooms with attached bath and a lobby/dining area), a reasonable parking space, two grassy lawns, an indoor hot water swimming pool, a separate kitchen block and a boundary. Further details with drawing and design of the property may be seen in the bidding documents which may be obtained from the office of the undersigned after publication of this Expression of Interest (EoI). The property has potential source of generating significant revenues and be utilized by carrying out renovation, refurbishing and internal beautification.
