01. Single stage two envelopes bidding (Two separate envelopes marked as **Financial Proposal** and **Technical Proposal** in bold must be submitted.)
02. Tender will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at Governor's Secretariat Gilgit-Baltistan, Gilgit.
03. Contractors/Suppliers may offer only for that category of tender in which they have complete setup (Own Shop/Store/Work Shop) with all documentary evidence.
04. The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of **Secretary to Governor Gilgit-Baltistan** must be attached with the technical documents. Following attested documents should be mandatory lacking of any document will result in disqualification:- (i). Own shop/workshop with documentary evidence (ii). Call Deposit of schedule Bank (iii). 5 yrs relevant work experience after registration (iv). Firm Registration Certificate (v). Six months latest Bank statement (vi). Non Black listed Affidavit. CNIC of owner, letter pad with complete address of shop/Workshop should also be attached.
05. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
06. Irrational/artificial and dubious rates offered by the firms/contractors will be rejected.
07. All kind of taxes applicable (if any) will be inclusive in the bid price and will be borne by the firms/dealers/suppliers/contractors.
08. The Competent Authority reserves the right to accept or reject any one or all the tenders as per relevant instructions/guidelines of GB PPRA Rules, 2022.
