- Original renewal receipt in Works Department GB is required for the financial year 2026-2027
- Copy of National Identity Card (Owner of the firm)
- Only Project specific power of attorney on the behalf of CEO/MD/Director of firm is accepted if provided on judicial stamp paper duly sign and stamp by 1st Class Magistrate
- Firms/JVs must provide earnest money in the form of call deposit receipt (CDR) in favor of the Executive Engineer B&R Division C&WD Ghizer from any scheduled bank.
- In case of receipt of abnormally low bids below 15% from technically sanctioned cost, the bidder must provide an additional performance guarantee (differential) amount equal to 10% of the difference amount between bid and TS cost) in shape of CDR only from any scheduled bank of Pakistan in favour of the Executive Engineer C&WD Ghizer as indicated in NIT which should be submitted along with the financial bid and Insurance Guarantee will not be entertained for this purpose.
- The bids having bid price lower than 25% shall be liable to be rejected. In case of same disputed rates within 25% initially rates upto three decimal places shall be assessed for the competition.
