The interested prospective eligible bidders can obtain a complete set of Bidding documents from the office of the **Deputy Director of Water Management & Irrigation Department District Diamer** on submission of a written application and production of the following original documents personally for the specific work duly deposited the cost of bidding documents through Treasury Challan as mentioned above against each work, immediately after the advertisement published in the newspapers & GB PPRA Website:

- i. PEC valid registration 2027 in relevant Code.
- ii. Renewal Fee CFY 2026-27
- iii. CNIC of the prospective bidder.
- iv. Bid security in the shape of CDR from any scheduled bank of Pakistan.
- v. No sick scheme and no litigation certificates

2. All bids must be accompanied by bid security as indicated above against each work and in case of rates quoted below 10% of estimated cost shall be required to provide along with the bid an additional performance guarantee of 50% of the differential amount (between estimated cost & bid cost) in the shape of CDR/Bank Guarantee from any schedule Bank clearly mentioning the name of the firm in favor of **Deputy Director Water Management & Irrigation Department District Diamer**. The sealed bids must be delivered on due date & time as mentioned above, which will be opened on the same day in the office of the **Deputy Director of Water Management & Irrigation Department District Diamer** in the presence of bidders who choose to attend at the same address.

3. OTHERS TERM & CONDITIONS:

- i. All bid securities/CDRs will be retained until the tender/bid is accepted and refunded after the tender/bid is accepted.
- ii. The information provided by the bidders if found ambiguous will be verified and in case of fake one, the tender of the firm will be canceled and face immediate/appropriate penal action as per Rules/Laws.
- iii. Late receipt of bids from the SCHEDULED TIME will not be accepted/entertained.
- iv. In accordance with procurement guidelines, Bidding Documents fees must be deposited into the Government Treasury via a **Treasury Challan** under the prescribed non-tax revenue heads, and the original receipt must be attached to the bid proposal to avoid disqualification.
- v. WM&I GB authorities reserve the right to reject any or all the bids or proposals at any time prior to acceptance of a bid or proposal under GB. PPRA Rules.
