





INVITATION FOR BIDS

1. The LG&RD District Gilgit represented by Executive Engineer LG&RD District Gilgit, (the "Employer") has received funds from Government of GB through GB-ADP # CMSDGs-191 for **Acquisition, Rehabilitation, Restoration and maintenance of Grave yards in GBA-I Gilgit-1(Through LG&RD)** and invites sealed bids from eligible bidders (Single entity or in JV) on **National Competitive Bidding (NCB) procedures** who can prove their eligibility and qualification as mentioned in the Bidding Documents for the works and have not been Black Listed by any Government agency/department/organization. The Bidding is open to all Eligible Bidders. The major scope of Work includes:
 - *Construction of boundary walls/retaining walls*
2. The Employer invites sealed bids, under **Single Stage-Two Envelope (SSTE)** bidding procedure as per GBPPRA Rule 39(b) from eligible firms or persons licensed by the Pakistan Engineering Council renewed up to 30th June 2026, in the relevant category/code for the Works.
3. The bidding documents can be obtained from the office of the **Executive Engineer LG&RD District Gilgit located at Shaheed-e-Millat road Gilgit** from the date of publication till **03-10-2025** during office timings. Tender fee of Rs 12000/- (non-refundable) in the form of Cash along with Bid Security in the shape of CDR from any scheduled bank of Pakistan in favor of Executive Engineer LG&RD District Gilgit to be attached with the application for issuance of bidding documents. Bidding documents will be issued by applying on original letter-pad by owner of firms or their authorized representatives having registered power of attorney of the firm mentioning the name of project (on affidavit). No proxy will be allowed to participate.
4. All bids must be accompanied by a Bid Security amounting to **Rs. 2400000/-** (Twenty-four lac only) in the form of CDR from any scheduled bank of Pakistan in favor of the Executive Engineer LG&RD District Gilgit and is to be **made part of Technical Bid**.
5. The completed bids must be delivered to **Executive Engineer Office LG&RD District Gilgit located at Shaheed-e-Millat road Gilgit** at or before 11:00 Hrs on 06-10-25. Bids will be opened at 11:30 Hrs. on 06-10-25 at the same venue, in the presence of bidder's representatives who choose to attend.
6. The Employer may not be responsible for any cost or expenses incurred by the bidder in connection with preparation or delivery of the bid.
7. Additional performance guarantee will be governed through **sub clause 28** of bidding data sheet.
8. In the case of gazette /Local Holiday tender will be opened on next working day without further intimation and time completion period of the project is 24 months.
9. The Employer reserves the right to accept or reject any bid and to annul the bidding process and reject all bids in line with GBPPRA Rule 36 of 2022, at any time prior to award of Contract.
