1. Proof of Firm Registration SECP/FORM-C, Active taxpayer with FBR (unless exempted under any law/rules).
2. Undertaking that the firm has not been blacklisted or debarred by any Government organization.
3. A capacity statement on available IT equipment (software/hardware) relevant to the assignment and having authorization certificates.
4. Single Stage Two Envelope as per Rule 39(a) of GBPPRA Rules 2022 method will be adopted.
