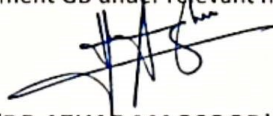

03. Tender documents will be followed according to GB PPRA rule 2023.
04. The Bid security Call Deposit in shape Bank Draft/CDR by Bank in the name of DDO 30 Bedded Hospital Muhammad Abad Danyore may be attached with the bidding/tender documents. No tender without call deposit will be accepted.
05. All the rates of the items mentioned in the tender documents should be quoted in computerized. The rate quoted in handwriting will be rejected.
