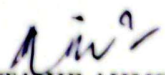

Terms and Conditions:

1. Sealed tenders may be submitted to the undersigned on or before the date/time mentioned against each category which will be opened on the same day/time in presence of the Contractors/Suppliers or their authorized representatives at Secretary Health Gilgit-Baltistan office New Secretariat Jutail, Gilgit.
2. Contractors/Suppliers may offer only the category of tender, in which he has complete setup (own shop/store/auto shop), technical experts/workers/staff, vast and past experience with documentary evidence.
3. The Contractor/Supplier must be sole proprietor having his own complete setup (shop/store/ auto shop) containing adequate supplies in Gilgit Town as well as at Rawalpindi/Islamabad or authorized dealer/agent at Islamabad/Rawalpindi and he will be bound to supply demanded items to the Secretary Health Gilgit-Baltistan office/DHS Camp Office Rawalpindi/Islamabad.
4. The bid must be accompanied with the call deposit mentioned against each category of tender above.
5. The Bid Security/call deposit in shape of Bank Draft/Pay Order issued by the schedule bank in the name of DDO, Secretary Health Office Gilgit-Baltistan, be attached with the bidding/tender documents. Tender without call deposit from the schedule bank, will not be accepted.
6. If any Contractor/Supplier intends to participate in more than one Tender above, separate bid for each separate category of Tender must be offered, mentioning the name of Category in **bold letters** on envelop.
7. The bidding documents of only registered firms/dealers/suppliers/contractors shall be entertained.
8. The rates of those items which are not included or covered after award of Tender to a successful bidder in the "Prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply/delivery.
9. All kind of Taxes, custom duties applicable (if any) may be included in the bid price and shall be borne by the firms/dealers/suppliers/contractors.
10. Conditional, ambiguous, incomplete and hand written tenders shall not be accepted.
11. Bidder with irrational rate shall be rejected.
12. Bank statement for last 02 years, work Experience in relevant field, Registration Certificate and Affidavit for Non-blacklisting and other supporting papers as mentioned in the bidding document must be attached with the sealed tender duly attested.
13. Tender documents fee must be submitted in Government Treasury failing which the bid will be rejected.
14. The Secretary Health Gilgit-Baltistan, Gilgit reserves the right to accept or reject any one or all of the tenders as per relevant instructions/guidelines of GB PPRA.
