1. Single Stage – Two Envelope (SSTE) bidding procedure shall be followed as per the Gilgit-Baltistan Public Procurement Regulatory Authority (GBPPRA) Rules. Technical and Financial Proposals must be submitted in separate sealed envelopes
2. A complete set of bidding documents can be obtained by interested bidders on submission of a written application along with relevant documents (PEC valid registration up to 31 Jun 2026, renewal fee receipt for 2025-26, CNCI, NOC for "No Sick project & No Litigation Certificate" and CDR from any scheduled bank of Pakistan) from the office of the Executive Engineer LGRD Ghizer by depositing the cost of bidding documents (Non-Refundable) as shown above on any working day during office hours. Bidding documents shall not be issued on the opening day.
3. All bids (Technical) must be accompanied by a bid security as stated above from any scheduled bank of Pakistan in favor of the Executive Engineer LGRD district Ghizer and must be delivered to the Executive Engineer LGRD DISTRICT Ghizer on the date & time mentioned above. Bids will be opened after 30 minutes of the closing time on the same day in the presence of bidders or authorized representatives who choose to attend at the same address.
4. Terms & conditions and qualification criteria are available in the bidding documents as bidding data sheets and appendices.
5. All bidders will be informed about the evaluation report as per GB PPRA Rules, and financial bids of only responsive bidders will be opened.
6. Original PEC registration certificate, CNIC of the owner, and firm's stamp must be attached with the documents.
7. The Procuring Agency reserves the right to reject any or all bids before acceptance under GBPPRA Rule-36.
8. The firm/contractor must submit an affidavit confirming that they are **not blacklisted** by any Government/Semi-Government/Autonomous organization.
