Terms & Conditions

- All bids (technical) must be accompanied with **3% Earnest Money E/M** clearly mentioned the name of the firm in the shape of CDR from any scheduled bank of Pakistan in the name of **DEPUTY DIRECTOR WATER MANAGEMENT & IRRIGATION DISTRICT GILGIT.**
- Contractors/Firm shall provide the latest Certificate of No Litigation/No Sick Projects with any other Government Departments (attested by 1st class magistrate).
- The contractor who quoted tender rates more than 10% percent below of T/S cost shall be required to provide along with bids an additional performance guarantee of 50% of the differential amount (between TS and bid) in shape of CDR from any scheduled bank of Pakistan. In case of failure to produce the required differential amount of bid by the bidder along with his bid documents shall be rejected.

d) Overwriting on bidding documents is not allowed, and in case of any overwriting/omission is found, the bid shall be rejected.

e) Conditional Tender will not be accepted/entertained.

f) Only project specific Power of Attorney on the behalf of CEO/MD/Director of firm is accepted if provided on judicial stamp paper duly attested by 1st Class Magistrate.
