TENDER TERMS AND CONDITIONS

1. The Tender Documents / RFP containing detailed terms and conditions can be obtained from the office of the Director General, Gilgit-Baltistan Disaster Management Authority (near Jail Building, Minawar Gilgit), during working days from 9:00 AM to 4:00 PM, up to the 12th March 2026, 10:00 am.
2. The bidders must possess a valid **certificate of Manufacturers/Authorized Distributors for rescue long range drone.**
3. The bidders must possess a valid **certificate of Manufacturers/Authorized Distributor or supplier for tactic drone.**
4. The bidder must have **experience in the supply of at least three (03) similar projects.** (Supply orders completion must be **duly attested** by the concerned department/organization).
5. A copy of the tender shall only be issued either in person or through an authorized representative, upon production of an original CNIC with valid **Manufacturers/Authorized Distributors /Supplier** as per para-4/N and para-5/N.
6. The bidder must have **valid & updated PEC/SECP/Firm-C registration** for the current financial year
7. The **Single-Stage, Two-Envelope procedure** will be adopted as per GB PPRA Rule.
8. **Sealed envelopes** must clearly mention the tender title.
9. All tenders must be accompanied by the required earnest money from any scheduled bank, in the form of CDR in favor of DG GBDMA. **The CDR must be attached with the Technical Proposal.**
10. Tender documents must reach the office of the Director General, Gilgit-Baltistan Disaster Management Authority (near Jail Building, Minawar Gilgit), by **12th March 2026, 10:00 AM.** The tenders will be opened on the same day at **10:30 AM** in the presence of bidders or their authorized representatives, by the **constituted committee** at the office of DG GBDMA, HQ.



11. **Overwritten, ambiguous, conditional**, or incomplete tenders shall be liable to rejection.
12. In case of any deviation or conflict in bidding procedures, the provisions of **PEC & GB PPRA Rules, 2022 shall prevail**.
13. The **Performance Guarantee shall be 10%** of the contract amount.
14. The interested firms must provide an **attested affidavit from gazetted Officer of No Litigation and Non-Blacklisting (where applicable, in case of foreign bidder NOC from the relevant ministry)**.
15. The successful firm shall be bound to supply the items at the GBDMA Main Warehouse, Minawar Gilgit, within the timeline specified in the **contract agreement**.
16. The tender copy fee must be deposited in the **Treasury Office Gilgit**, and the original deposit slip must be **attached with Technical Proposal**.
17. The Procurement Committee reserves the right to accept or reject any or all bids at any stage prior to the acceptance of a bid or proposal, without assigning any reason **as per GB PPRA Rule 36**.
18. The procuring agency shall disqualify suppliers if, at any time, it finds that the information submitted regarding qualification was false, materially inaccurate, or incomplete, as per **GB PPRA Rule 21**.
19. **No dollar parity** shall be entertained. Only the quoted rates submitted by bidders shall be considered until the completion of supplies as per the Contract Agreement (CA).
20. Bids which are incomplete, not sealed, not signed and / or not stamped, late or submitted by other than specified mode will be rejected.
21. The bidders shall quote the prices (inclusive of all taxes and duties) of all items. The contract shall be awarded to the lowest evaluated bidder.
22. Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificates must be provided with the Bid
