TENDER NOTICE

The Directorate of Mines & Minerals, Gilgit-Baltistan, invites sealed tenders from well-reputed and registered firms for the supply of Office Equipment / Machinery (**Lot-A**) and Furniture (**Lot-B**) under the project "Upgradation of Lapidary Centre Gilgit and Skardu (EDF)". The procurement shall be carried out through the Single Stage-Two Envelope bidding process in accordance with Rule 39(b) of the GB-PPRA Rules, 2022.

1. The Participating Firm must be registered either with Security Exchange Commission of Pakistan or District Registrar (Form-C).
2. Bid security amounting to five (5) percent of bid value in the shape of Call Deposit should be attached with the quotation. In case CDR not found attached with Technical Bid the firm / contractor will be declared as "Non-responsive".
3. Successful bidders will have to submit 10% Performance Security from any Schedule Bank in the name of Director Mines and Minerals, Gilgit within seven(7) days after bid acceptance.
4. The bidder must have maintained a minimum average bank balance of PKR 02 (two) Million in a scheduled bank account for the last twelve (12) months preceding the submission date of the bid.
5. Conditional/Optional quotations will be treated as "Non-Responsive".
6. Irrational rates / Unrealistic rates will not be considered and rejected.
7. An affidavit on Stamp Paper of Rs. 100 must be accompanied with the tender documents to the effect that a bidder has never been blacklisted by any government/semi-government organization/ PPRA.
8. The Directorate of Mines and Mineral GB is fully empowered to accept or reject all or any of the proposals as per GB Public Procurement Rules, 2022 on the basis of sound reasons thereof.
9. Bidders are required to submit a separate tender for **Each Lot** they intended to participate in. A single tender covering multiple lots will not be accepted and shall be rejected without evaluation. The lot number must be clearly mentioned on each envelope.
10. All submitted bidding documents must be typed and printed. Handwritten bids shall be rejected.
11. Bids received after closing date and time will not be accepted.
12. The number of items can be increased or decreased keeping in view the availability of financial resources for the purpose.

3. The Tender Document can be obtained only from the Office of the Directorate of Mines & Minerals, KIU Road, Konodas, Gilgit, during office hours on payment of non-refundable amount of Rs. 2000/-(Two Thousand only) for one bid.
