- i. Bidding documents shall be issued to the Govt. Constructor/Firms in person on production of original CNIC, Registration with PEC and renewal fee receipt 2024-25 of Works Department GB and upon production of Call Deposit.
- ii. Constructors /Firms should provide 2% bid security as mentioned in shape of deposit at call, in the name of Executive Engineer Building Division C&WD GB Gilgit from any schedule bank of Pakistan.
- iii. Bid security shall provide to department for verification of relevant bank.
- iv. Bidding documents shall not be issued to constructors who have delayed already awarded projects.
- v. Bidding documents will not be issued who have blacklisted.
- vi. Conditional bid shall not be acceptable to the department.
- vii. Unbalance quoted rates will be dealt as per rule/policy mentioned in bidding documents.
- viii. The Procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under the provision of Rule-36 of GB PPRA Rules 2022.
- ix. All terms & Conditions of procurement processes revised General guidelines issued by Works Secretariat vide No. Sec-SO-D-9(28)/2022-23/475 dated 26-01-2023 for bidding / tendering process /able with effect from 1<sup>st</sup> Feb, 2023 and PEC bidding documents shall be part of Procurement (copy of revised tender policy 2022-23 also a part of bidding documents).
