Terms & Conditions:

- i. Firms/Contractors are required to provide mandatory documents as at serial#2 to become eligible for technical evaluation process. No Firm/Contractor shall be eligible if any document is missing.
- ii. Technical evaluation shall be made as per criteria mentioned in tender documents.
- iii. Financial proposal of only those Firms/Contractors shall be opened who have obtained minimum 60% marks in technical proposal/bid.
- iv. Experience of one year (period of 12 months) starting from 1st July to 30th June of every financial year. Firms have to produce proper experience certificate which can be verified from the department concerned.
- v. Tender rates must be typed computerized and rates must be filled in all boxes/space, No blank is acceptable.
- vi. Un realistic rates i.e **Rs.5, 10, 50, 100 and above 20% of market and below market rates** will not be considered if found their bid shall be rejected without intimation.
- vii. Supply order for supply of single item shall not be considered as experience.
- viii. All photocopies of requisite documents should be attested by Gazetted officer otherwise their bid will be rejected.
- ix. According to GB PPRA Rule single-stage two envelope procedures will be adopted.
- x. Every contractor will be paid an amount of **Rs.10000/- on account of Repair/Maintenance of Govt. vehicles, Rs.5000/- on Stationery and Misc. items respectively** on account of Tender documents fee and the same will be deposited through Treasury Challan and a copy shall be attached with tender documents.
- xi. Ten million balance is mandatory on 30th June, 2026 in Firm's own account (only for repair of vehicles).
- xii. The Secretary S&GA & Cabinet/PAO reserves the right to reject any one or all of the tenders as per relevant instructions/guidelines of GB PPRA.
