Tenders, in sealed envelopes, as detailed/specified in bidding documents, for DDO Deputy Director Education Skardu for Financial Year 2026-27 (ending on 30th June 2027), for printing of exam materials question/answer scripts award list etc and miscellaneous items (including packing/delivery charges) is hereby invited from the eligible/registered Govt. Contractors/Firms on the date & time mentioned below which will be opened by Chairman procurement committee, in presence of the contractors or their authorized agents who care to attend, on 23-09-2026 at 11:30(AM) at the office of Deputy Director Education Office Skardu.

TERMS & CONDITIONS:-

1. The tender rates will stand valid only for procurement of the items listed.
2. The tender/bidding document of only registered firms/dealers/suppliers/contractors which have printing press and warehouse in Skardu shall be entertained
3. Prices must be quoted separately for each individual item but shall be decided on a lot basis
4. Rates should be quoted inclusive of all applicable taxes and delivery charges.
5. The rates quoted by the bidder shall be reasonable and in line with prevailing market rates. If, during evaluation, the quoted rates are found to be unreasonably higher/lower than the prevailing market rates, the bid may be declared financially non-responsive/rejected in accordance with the applicable procurement rules and the evaluation criteria specified in the bidding documents.
6. The Procuring Agency reserves the right to verify the quoted rates through market survey/market rate analysis and other relevant sources before finalizing the procurement.
7. Incomplete bid documents with incomplete details(specifications/strength/manufacturer etc) shall be rejected straight away.
8. 2% of the bid value in the form of call deposit issued by a Schedule bank/KCBL GB may be deposited in favour of Deputy Director Education Skardu otherwise bids shall be liable to be rejected technically.
9. Successful bidders shall have to submit 10% performance security in shape of CDR/Pay orders within 10 days after bid opening.
10. The bidder shall ensure timely delivery of the printed material at the designated places. Any delay or failure in delivery shall attract the applicable contractual terms/penalties.
11. The Chairman of procurement committee reserves the rights to accept or reject in part or whole of tender on violation of any financial rules/assigning recorded reasons there-off.
12. Bidder will be selected on the basis of the rates offered other mandatory terms and conditions and his experiences & performance in relevant field experience.
13. The Company/Firms Shall have to submit affidavit for not have been blacklisted on legal stamp paper worth Rs.50/-.
14. Tender process will be completed in accordance with the relevant rules of GB PPRA 2022 (as amended and guidelines issued there under from time to time).
15. Bidding documents can be obtained from the office of the DDO Deputy Director Education Skardu on 22 September 2026 @ the fee as per Finance Act-2025
16. Single stage two envelop process will be adopted (One sealed envelope containing both sealed technical and financial proposals separately.)
17. Tender will be opened on 23 September, 2026 (11:30 AM) at DDE Office Skardu.

19. All the items will have to be supplied at the concerned DDO/schools. Detail can be obtained from DDE Office Skardu. Rates will be inclusive of all relevant taxes and supply/other charges.
