- 2. The firms/contractors must submit application for issuance of bidding documents to the undersigned with the following documents:
- Registration with Pakistan Engineering Council in category C-6 and above having codes CE04 & CE10 duly renewed for the year 2025-26.
- b. Enlistment with Water & Power department Gilgit-Baltistan duly renewed for year 2025-26.
- c. The Bid Security as mentioned above in the shape of Deposit at Call provided by Scheduled Bank of Pakistan.
- d. Bank Statement showing turnover of 6.5 million and balance of 5 million for work at Sr#1 and, statement showing turnover of 4 million and balance of 3 million for work at Sr#2 on 30<sup>th</sup> September 2025.
- e. Work experience of at least two projects of hydraulic structure having contract value 9 million or above for work at Sr#1 and experience of at least two projects of hydraulic structure having contract value 6 million or above for work at Sr#2.
- f. No litigation and no blacklisting undertaking/certificate from the office of the Secretary W&P GB.
- 3. Complete set of bidding documents for the above mentioned work may be purchased by interested bidders or their authorized representative on production of the documents mentioned above with valid registered power of attorney in original and by submission of a written application from the office of the Executive Engineer W&P CED Ghanche and upon payment of non-refundable fee stated above in cash. Bidding documents shall not be issued after 17<sup>th</sup> October 2025 at 1600 hours.
- 4. The bids must be delivered at the venue the Executive Engineer W&P CED Ghanche at or before the above mentioned date and time and will be opened at the date and time as mentioned above in presence of bidders or their representatives who choose to attend at the mentioned venue.
