### GENERAL TERMS & CONDITIONS:-

- Bid security as mentioned above must be attached with the technical bid in form of Call Deposit (CDR) in the name of Assistant Director GBDMA Skardu from any schedule bank. The CDR must be in the name of shop/company. Ambiguous call deposits will be rejected.
- An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government organization/PPRA.
- The contractor must have his own relevant shop/workshop/outlet, to participate in the tender. Firms/contractor having minimum **3-year relevant experience** (with supply order/experience certificate/proof of experience must be attached with the tender documents) can only participate in tender. Firm Registration Certificate, CNIC of the owner, letter pad of the firm with address, vendor and telephone number should be incorporated in the bidding document. The tender procuring committee can verify it from issuing departments where deem necessary.
- Tender with incomplete supporting documents shall not be accepted and furnishing incorrect information shall be liable to legal action.
- Irrational/artificial and dubious rates (low or over exaggerated rates of items as per market rates) offered by the firm/contractor will be rejected.
- The rates of items not enlisted in the "**Prescribe Form**" will be determined in accordance with the prevailing retail price /market rate at the time of supply. The contractor /supplier will not have the right to challenge the market rates collected from the market by the tender procuring committee.
- The responsive firm shall be bound to supply/provide goods/services on rates quoted for light and heavy machinery in tender documents during Financial Year 2025-26.
- The procedure **Single Stage Two Envelope** shall be followed and tender shall be evaluated as per 39 (b) of GB PPRA Rules.
- The department reserves right to accept or reject tender according to GB PPRA Rule-36.
- Sealed tender documents must reach at office of the undersigned on or before the dates and time mentioned above. Tender documents will be opened on the same day as schedule given above in presence of contractor or authorized representative.
- Tender documents (light and heavy machinery) may be obtained from the office of the undersigned during office hours.
