The tender documents must reach office of the Gilgit-Baltistan Emergency Services (Rescue 1122) H/Q, near Heli Chowk, Jutial Gilgit on or before the date mentioned above. The tender documents will be opened on the same day as per schedule given above in the presence of contractors or authorized representatives.

GENERAL TERMS AND CONDITIONS: -

01. Tender documents can be obtained from the office of the Director General GBES (Rescue 1122) till 16th September, 2026 closing office working hours on written request with original treasury slip/challan by depositing **Rs.4000/- (Rupees Four thousand only)** as tender fee in Treasury Office.
02. Earnest money as mentioned above must be attached with the tender documents in the shape of DD/Pay Order (Refundable) in the name of Deputy Director GBES Rescue 1122 from any schedule Bank.
03. Tenders with incomplete supporting documents shall not be accepted and furnishing incorrect/false information shall be liable to legal action.
04. Offer must be in Pak Rupees inclusive of all Taxes applicable (if any) to be borne by the firms/dealers/suppliers/contractors.
05. Conditional, ambiguous, incomplete, irrational rates and hand written tenders shall not be accepted.
06. Bids quoting irrational, unrealistic or unreasonably low/high rates shall be rejected outright without further consideration.
07. An affidavit on stamp paper of Rs.100/- must be accompanied with the tender document to the effect that the bidder has never been black listed or barred by any Government/semi Govt. organization /GBPPRA.
08. Rates quoted should be for genuine items and contractor will be bound for warranty where required.
09. The firm has minimum 5 years relevant Experience. Experience certificates must be attached in the form of supply/work orders/contract agreement etc.
10. Separate transportation charges will not be allowed.
11. The firm/contractor shall be bound to supply the items to GBES (Rescue 1122) HQ office Gilgit till 30th June, 2027.
12. Contract shall be terminated on issuing 15 days' notice or /any time before if the department feel dissatisfied with the performance of the contractor.
13. The bid shall be considered lot wise and firm shall be bound to supply/provide goods/services at rates quoted in tender during the financial year **2026-27**.
14. **Single stage- two envelope** procedure shall be followed as per **GBPPRA rule 2022 Rule 39(b)**. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the **Financial Proposal** and **Technical Proposal** and also marks in bold and legible letters.
15. The Department reserves the right to accept or reject any one or all the tender according to **GBPPRA rule-36(1)**.
16. It may be checked and ensure that all the cells of the Rate offering column have been filled in and no cell is left unfilled without offering the tender rate against the items (**Including Grant & Sub Totals**). If any cell found unfilled or empty, the bidder will be rejected.
17. Bids received after the due date and time will not be entertained.
18. The rates quoted in the bid should include laboring charges. Separate labor charges will not be allowed.
19. If district Administration will announce local holiday on 17th September, 2026, the bid will be opened the very next working day.
20. Other terms and conditions are mentioned in the tender documents must adhere by the firms and tenders will be evaluated as per terms and conditions accordingly.
