INVITATION TO BID (SSTE)

In pursuance of the decision of the Grievance Redressal Committee (GRC) conveyed vide letter No. Sec-SO-D-9(18)/2026 Dated 14th Sept. 2026. The Executive Engineer B&R Division Skardu invites sealed bids (Technical & Financial Bids) eligible Firm/Contractor/JV registered with Pakistan Engineering Council in the relevant category/code duly updated and having relevant experience under GB PPRA Rule 2022 under single stage two envelope (SSTE) procedure for the work mentioned below: -

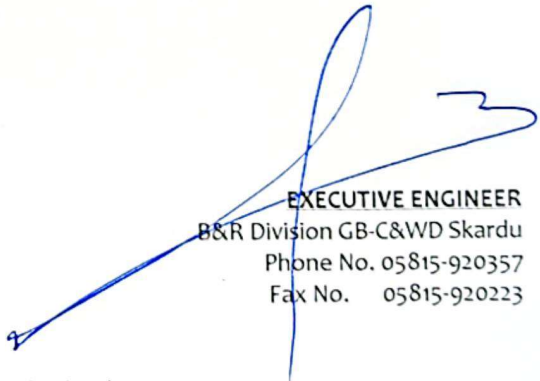

1. MANDATORY CONDITIONS: -

- Registration with PEC for CFY (2026-27) with relevant code and category.(as per extension by PEC)
- Renewal receipt GB-C&W Department for CFY (2026-27).
- Latest profile of the constructors/firm/JV from PEC website
- As per directives of Works Secretariat vide Notification No.SW-7/104/Notification/2022-23/3369 dated 18-08-2023, mandatory certificates regarding "No Sick Scheme certificate will be provided to contractor on production of challan of Rs. 5000/- and "No Litigation" will be provided to contractor on production of challan of Rs. 5000/- the mentioned fees shall be deposited in Government treasury through treasury challan and the copy of challan shall be part of each bidding documents of enlisted contractors.
- The competent authority of GB C&WD reserve right to reject any or all application/bid prior acceptance of the application/ bids as per GB PPRA Rule 2022 under clause-36(1).
- CNIC of the Prospective bidder/firm.
- Bid security as specified in shape of CDR from any scheduled bank.
- Page numbering & signing of each page in original shall be mandatory.
- Only one bid will be entertained either as single bidder or JV partner.
- Bank statement should be properly stamped and signed by the concerned Bank Manager.
- The Qualification and Evaluation Criteria is enclosed with the bidding documents. All bidders are directed to fill the form duly certified on an affidavit on a judicial stamp paper of Rs. 100.
- The Bidding documents are available for a non-refundable fee of Rs. 14,000/- (Rupees Fourteen Thousand Only) in shape of Treasury Challan duly passed by the Treasury Officer / NBP Skardu Branch, showing the name of project and constructor. Treasury Challan must be printed hand written not accepted.
- Submission of fake, incomplete and faulty documents will be rejected and legal action will be taken accordingly.

GENERAL GUIDELINES.

- i. The Contractor debarred by any region/division and notified by Works secretariat shall not be eligible to participate in the bidding process in all regions.
- ii. The bid security of unsuccessful bidders shall not be released prior to acceptance of bid by the competent authority.
- iii. The bidding documents/tender copy fee may be charged in accordance with the GB Finance Act-2026 given vide schedule-I (Section-12).
- iv. The bidder may submit 02 sets of bidding documents duly addressed to concerned Executive Engineer and one duplicate copy may be addressed to relevant Chief Engineer to ensure transparency.
- v. The pre-bid meeting will be held in the office of the Chairman bid Evaluation committee/Superintending Engineer GB PWD Skardu/Shigar Circle Skardu on 25th Sept, 2026 at 11:00 AM.
- vi. No bid shall be accepted beyond closing of time as mentioned above.
- vii. In case of any deviation, conflict in bidding procedure the provision of GB PPRA 2022 shall prevail.
- viii. In case of local holiday bid will be opened on next working day without further intimation.
- ix. Clarification of bids shall only be allowed in accordance with GB PPRA Rule 2022 and Standard Bidding Documents relevant clauses.
- x. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank in shape of CDR/ Bank Guarantee or AA rating insurance company duly rated by PACRA or any other SECP recognized credit rating agency.
- xi. Bids shall be opened in the Office of the Chairman bid Evaluation committee/Superintending Engineer Skardu/Shigar Circle on given time and date.
- xii. Rates quoted below 10% of the Technical Sanction shall be considered as unworkable and default; however,
 - a. The bidder who quotes rates below 10% of T/S shall be required to provide along with his bid, an additional performance guarantee of 50% of the differential amount (between T/S and Bid) in shape of CDR from any schedule bank of Pakistan along with his financial bid.
 - b. In case of failure to produce the required differential amount by the bidder along with his financial bid, the bid shall be rejected along with forfeiture of bid security of bidder.
