- i. Earnest money, as mentioned against each item, must be attached with technical proposal of bid documents in the form of a demand draft or pay order in the name of General Manager Admin, NATCO, issued by any scheduled bank.
- ii. Tender documents must reach the office of General Manager Admin, NATCO, on or before the closing date and time mentioned against each item. Tenders will be opened on the same day at the specified time in the presence of the contractors or their authorized representatives.
- iii. Tenders with Incomplete supporting documents shall not be accepted, and furnishing incorrect information shall be liable to legal action.
- iv. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government Organization/PPRA/GBPPRA.
- v. Firms quoting inappropriate rates (even of a single item) with respect to market rates, shall not be considered.
- vi. Vendors must have at least Five (05) years of experience in the provision of the same Items/work for the category they are applying for. Relevant supply orders, experience certificates, or other proof of experience must be attached with the tender documents.
- vii. The procedure of single stage two envelope shall be followed, and tender shall be evaluated as per weightage/ratio of 70:30 formula "70 for technical proposal and 30 for financial proposal". Firm/Contractor needs to submit separate proposals for Technical & Financial clearly indicating the name of Firm/Contractor. Documents provided in a single envelope shall not be considered and shall be rejected.
