TERM AND CONDITIONS:

- A complete set of bidding documents containing detailed terms and conditions may be purchased by interested eligible bidder/authorized representative on submission of written application on original letter head accompanied by the following documents mandatorily.
 - PEC valid registration certificate for CFY(2025-26)
 - CNIC of the prospective bidder/firm.
 - Bid security as specified in shape of CDR only (pay order not accepted) for any scheduled bank in favor of Executive Engineer LG&RD Skardu.
 - Registration/Renewal fee slip of financial year 2025-26 with LG&RD Department.
- 2. Tender form will not be issued to the contractors having sick or slow moving projects.
- 3. The procuring agency may reject all bids or any one at any time prior to the acceptance bid or proposals under the provision of GB PPRA rules 2022.
- 4. Rates quoted below 15% of T/S amount, the bidder shall have to submit and additional 100% of difference amount between TS and rate quoted as performance guarantee in shape of CDR along the bidding documents otherwise the bid shall be rejected.
- 5. Contractors/firm rates quoted below 100% in any sub-heads or in any items bid shall be rejected.
- 6. The bidders quoted rates below 25% from TS shall liable to be rejected.
- 7. Incomplete and lump sum bid shall be rejected.
- 8. Power of attorney should be on Rs.100 stamp paper in original mentioning the project name and name of representative by attestation of 2nd class magistrate is monetarily.
