Minutes of Meeting of procurement committee for the Opening and Evaluation of Technical Bids for the Procurement of Biomedical Equipment (128-Slice CT Scan Machine) under the Development Scheme "Missing Facilities for Shaheed Saif-ur-Rehman Hospital, Gilgit" (ADP No. 906)

The agenda of meeting was to open and evaluate the technical bids received for the procurement of a 128-Slice CT Scan Machine under the above-mentioned development scheme.

The tender advertisement for the said procurement was published on the GBPPRA website on 8th August 2025 under Tender Notice No. TSE-202508081647, and subsequently in newspapers on 13th August 2025 with reference No. IDGB#673/25. The advertisement appeared in *Business Recorder (Islamabad)*, *Daily Ausaf (Islamabad)*, *Daily Sadaye Gilgit*, and *Daily GB Express*.

The pre-bid minutes of meeting were already communicated to all the bidders.

A total of three (03) bidders submitted their proposals to the Procurement Committee on 10th September 2025 at 11:00 a.m., in accordance with the schedule specified in the tender advertisement.

The Chairman welcomed all members of the Procurement Committee as well as the participating bidders and briefed the participants on the agenda of the meeting. A total of three (03) sealed bid proposals, received within the stipulated time, were duly signed by the Procurement Committee on the outer envelopes. Each bid was then opened in the presence of the committee members and the authorized representatives of the bidders. The technical proposals were opened and duly signed by the Procurement Committee, while the financial proposals were kept sealed.

The bids were evaluated in accordance with the prescribed evaluation criteria, technical specifications set forth in the bid documents, the pre-bid meeting minutes, and the applicable provisions of the GBPPRA/Government procurement rules.

M/s Irfan Brothers International submitted a bid quoting the Fujifilm brand; however, the performance certificates provided are for Hitachi. This has created confusion for the Procurement Committee regarding the bid. Accordingly, the Committee has issued a letter to M/s Irfan Brothers International seeking clarification on the bid, specifically regarding the conversion/merger of the Fujifilm and Hitachi brands.

Observations, compliance status, and any deficiencies noted in each bid were recorded in the evaluation sheets (attached as Annexure-A).

1- The Technical Evaluation Report has been prepared on the basis of the documents and information submitted by the bidders in their respective technical proposals/bids.




