Tender Notice

Sealed tenders are invited from well reputed Government Registered contractors/firms/companies having sufficient experience in supply of furniture for **“1. Upgradation of BHS Bagyout into HSS Level 2. Construction of Additional Classrooms at BHS Takia, BMS Satellite Town and GHS Chilas 3. Construction of Additional Classroom at BPS Chakar Botogah”** for the FY 2024-25 against the approved development scheme upto 30th June, 2025.

Detail of furniture, legal and financial terms and conditions are available in the bidding documents: -

- i. The interested bidders may submit their bids in the office of the undersigned upto 11:30 AM on 30th April, 2025 which will be opened on the same date at 12:00 PM.
- ii. The bidder may obtain bidding documents from the office of the undersigned one day before closing date i.e. 29th April, 2025 @ **Rs. 4000/- (Rupees four thousand only)** for Furniture, plant & Machinery **and Rs. 2000/- (Rupees Two Thousand Only)** for Library Books and Science Equipments.
- iii. As per PPRA rules 2004, 2% call deposit (CDR) of bid amount from any schedule Bank may be attached with the Technical Bid/Tender in favour of **Deputy Director Education Diamer (Chilas)**.
- iv. Successful bidders will have to submit 10% performance security in shape of (CDR) from any schedule Bank within 7 days after bid opening.
- v. Furniture and all other items will have to be supplied at the respective Schools of District (Diamer). Rates will be inclusive of all relevant taxes.
- vi. Single stage one envelope bidding procedure will be adopted for competitive bidding as per PPRA Rules 2004 clause 36 (a).
- vii. Black listed, pending liabilities against the contractors and those contractors / firms/companies whose registration/renewal is not upto date will not be eligible for participation in the bidding process.
- viii. The bidder must have their own showroom, Karkhana and office in Gilgit Baltistan with sufficient human resource. Preference will be given to the bidders having approved dealership/distributor of ISO certified manufacturer of school furniture.
- ix. The tender will be based on items wise having relevant professional experience fulfilling all above terms and conditions.
- x. In case of any dispute the decision of the purchase committee will be considered final which will not be challengeable in any Court of Law.
- xi. The Chairman and members of the committee reserves the right to accept any one or to reject all tenders with assigning reasons thereof.
